## STUDENT RULES OF BEHAVIOR

In accordance with English Law, we have a legal duty of care towards our students. We will do our best to fulfill our 'duty of care' based on goodwill and trust established by you and your parents' agreement to the 'rules' as evidenced by the signed Application form.

Students will be courteous and polite to staff, teachers, home stay families and each other.

Examples of disorderly or forbidden conduct are:

- Threatening behavior and abusive language. Knives are forbidden.
- Suspected involvement with illegal drugs.
- Smoking outside designated areas.
- Entering accommodation of the opposite sex.
- Leaving accommodation after lights out.
- Theft, vandalism or inappropriate behavior.
- Anti-social behavior. Bullying in any form.
- Buying, selling or exchanging goods over £5 in value must be done through a member of staff.
- We assume that anyone with a person breaking a rule is also breaking that rule.
- Entering a licensed premises (a pub).

## SCHOOL DISCIPLINE AND LEGAL

Canterbury Steiner Summer School reserves the right to apply any suitable disciplinary measures to those who upset their fellow students, break school rules or English law. If the student continues to offend, we reserve the right to send them home, at the parent's expense and with no refund on fees paid.

Students will have to pay for any damage caused to property in their accommodation or on the school premises. Canterbury Steiner School will not be responsible for any injury to or by students or to any third party other than our common law legal liability in respect of negligent acts on our part. In no circumstances will we be responsible for consequential losses irrespective of how they are caused.

## INSURANCE

Parents must take out fully comprehensive insurance for the period of their child's stay in the UK to cover cancellation, medical expenses, personal injury, musical instruments, lost property and personal liability. This must be purchased in your own country before traveling.

Canterbury Steiner School cannot be held responsible for any costs incurred by students who are not insured.

## CANCELLATIONS

These must be made in writing and fees will be retained according to when notice is received.

Cancellation fees payable :

30 days or more before commencement of course £100 deposit retained.

29 days - one weeks fees retained.

7 days or less - full course fees retained.
